#### YOU WILL BE TICKETED FOR ANY INFRACTIONS BELOW!

Make sure all children understand that the electric gate is not a **TOY**! Children should no play around or near it. Use the electric gate for automobiles only. There is a pedestrian gate for foot traffic. No signs may be posted on the gate. This includes directional signs!

### **PARKING:**

- 1. Our policies require a permit for all cars inside the gate. The permit must be displayed in the vehicle. Vacation renters will be charged \$200.00 for any non-returned parking permit.
- 2. Please Park behind the white lines.
- 3. Parking: house trailers, buses, RV, or boat/boat trailers inside the gate is not permitted.

#### FIRES:

#### **PARTIES:**

#### **CAR RADIOS, AMPLIFIERS & SPEAKERS:**

Please turn down your car radio as you approach the gate and keep it low while driving inside the gate. Amplifiers and speakers are not permitted outside of residence buildings.

#### **SEAWALL:**

The seawall area in front of each residence is private property; please do not walk along the wall. Do not use the beach access stairs of any private residence apart from the house you are renting.

#### LAUNDRY:

We ask that you refrain from hanging laundry, including beach towels and bathing suits, from balconies.
